AMEB (NSW) Private Venue Requirements for COVID-19

As the COVID-19 restrictions are being relaxed, a number of decisions are being made on how to best examine AMEB candidates in 2020. We are hoping to support those teachers, schools and regional conservatoriums that want to hold AMEB exams in their private venues.

To comply with official advice from health authorities NSW Health and the Australian Government Department of Health in relation to coronavirus (COVID-19), there will be new mandatory requirements that private venue owners must meet for us to send an examiner. Only those venues that can GUARANTEE that they will meet the government standards will be eligible to be private venues while Public Health Orders remain in place.

Space requirements

Under rules from NSW Health (see <u>www.nsw.gov.au/covid-19/safe-workplaces</u>) you must have space for people to sit or stand 1.5m apart, and any indoor space must have at least four metres square per person.
